29 **WHEREAS**, AHFC desires that the Non-Profit Corporation's Certificate of
30 Formation and By-Laws be in the form and be executed, approved, and filed in the
31 manner prescribed by this Resolution; and

32 **WHEREAS**, the Board of Directors desires to authorize and approve the
33 Certificate of Formation and By-Laws of the Non-Profit Corporation, appoint the
34 board of directors and president of the Non-Profit Corporation, and take other
35 action with respect to the Non-Profit Corporation; **NOW, THEREFORE,**

36 **BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE**
37 **AUSTIN HOUSING FINANCE CORPORATION:**

38 **Section 1.** The Board of Directors finds, determines, recites, and declares
39 that it is wise, expedient, necessary, and advisable that the Non-Profit Corporation
40 be formed. The Board of Directors therefore approves the creation and
41 organization of the Non-Profit Corporation under the provisions of the Code as a
42 duly constituted affiliate, nonprofit corporation, and instrumentality of AHFC. The
43 Board of Directors authorizes the Non-Profit Corporation to develop housing for
44 low-income individuals and families as a primary activity to promote community
45 based revitalization for the City; to aid, assist, and act on its behalf and for the
46 benefit of AHFC in the performance of its functions to acquire, rehabilitate,
47 develop, manage, and operate affordable housing in City of Austin; to acquire to
48 rehabilitate, develop, manage, and operate the Development; to promote, develop,
49 and maintain the Development as decent, safe, and sanitary housing at affordable
50 rental rates; to ensure the Development helps to achieve the public purpose and
51 functions of AHFC; and to perform the other purposes described in the Non-Profit
52 Corporation's Certificate of Formation. The Board of Directors approves the Non-
53 Profit's acquisition of the Development as described above and authorizes the
54 Non-Profit Corporation to enter into all documents necessary to complete such
55 transactions.

Section 2. The Board of Directors approves the Certificate of Formation of the Non-Profit Corporation in substantially the form attached as **Exhibit A** and authorizes the incorporator of the Non-Profit Corporation to file such Certificate of Formation with the Secretary of State of the State of Texas in the manner provided by law.

Section 3. The Board of Directors appoints the initial board of directors of the Non-Profit Corporation, with their terms of office to expire at the time indicated.

J. Rodney Gonzales is appointed as the President of the Non-Profit Corporation. Other officers will be appointed as provided in the By-Laws of the Non-Profit Corporation.

Section 4. The Board of Directors approves the By-Laws of the Non-Profit Corporation in substantially the form attached as **Exhibit B** and authorizes the President of the Non-Profit Corporation to execute and file them in the corporate records in the manner provided by law.

Section 5. The Board of Directors finds, determines, recites, and declares that no note, bond, loan, debt, or other obligation of the Non-Profit Corporation is an indebtedness, liability, general or moral obligation or pledge of the faith or credit of the State of Texas, the City of Austin, AHFC, or any other political subdivision or governmental unit. In addition, no note, bond, loan, debt, or other

obligation constitutes an indebtedness within the meaning of any constitutional or statutory debt limitation or restriction or an agreement, obligation, or indebtedness of AHFC, the City of Austin, the State of Texas within the meaning of AHFC's Articles of Incorporation, the City Charter, or of any constitutional or statutory provision whatsoever.

Section 6. The Board of Directors finds, determines, recites, and declares that it is the purpose, intent, and desire of AHFC in approving the creation of the Non-Profit Corporation and the form of its Certificate of Formation and By-Laws, that such actions and the Non-Profit Corporation hereby authorized comply with the requirements of the Internal Revenue Code of 1986, as amended, and the Treasury Regulations and Internal Revenue Service rulings promulgated thereunder and the rulings issued pursuant thereto, such that the Non-Profit Corporation is determined to be a constituted nonprofit corporation acting as an asset of AHFC pursuant to the provisions of the Code and Chapter 394 of the Texas Local Government Code.

Section 7. This Resolution takes effect immediately upon its passage and approval by the Board of Directors.
