

**MBE/WBE Summary**

Public notice was given for this solicitation (CLMC894, Burnet Road Corridor – Koenig Lane Intersection to White Horse Trail), through the City's Vendor Connection web portal. Three bids were received and opened on February 10, 2022. Of the three bids received none of the firms submitting were certified MBE/WBE. DeNucci Constructors, LLC submitted the lowest responsive bid including an allowance of \$100,000.00:
