Additional Backup Information:

The Austin Transportation Department (ATD) proposes to amend the Austin Strategic Mobility Plan (ASMP), which is the transportation element of the Imagine Austin Comprehensive Plan (Ordinance No. 20190411-033). The Charter of the City of Austin requires a public hearing at Council when Council desires to amend the Imagine Austin Comprehensive Plan. This item sets the required public hearing at Council and, if approved, will be advertised in the American Statesman and notification will be sent out to the Community Registry 16

days prior to the hearing date.

This is the first amendment cycle to the ASMP and was initiated by Council Resolution No. 20200610-002. This amendment proposes changes to the Policy Document and Street Network. The first draft of proposed amendments was released in two parts. The new proposed policies were released on October 1, 2021 and the proposed amendments to the Street Network were released on November 15, 2021.

The first round of public engagement concluded on January 30, 2022. On February 28, 2022, ATD sent notification to the Community Registry and initiated the second round of public engagement on an updated draft of the proposed amendments to the ASMP. In March, ATD presented an updated draft and collected public feedback at Boards and Commissions meetings and at the Council Mobility Committee meeting. Additionally, ATD collected public feedback throughout March. In April, ATD summarized the public feedback and created the final draft of the proposed amendments.

The final draft will be published in May prior to the Planning Commission meeting and to the public hearing at Council.
