

M/WBE Summary

Public notice was given for this Request for Qualifications CLMP330 2021 Field Engineering Services Rotation List, through the City's Vendor Connection web portal. Nine firms submitted qualification statements and responses were opened on January 26, 2022. Of the nine submittals received, six submittals were from MBE/WBE certified firms.

Participation goals stated in the solicitation were 1.90% African American; 9.00% Hispanic; 4.90% Native Asian; and 15.80% WBE. The recommended firms provided an MBE/WBE Compliance Plan that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department.
