Public notice was given for this solicitation CLMC851A for the Tennis Facilities - Pharr Tennis Center Renovations – Rebid project, through the City’s Vendor Connection web portal. One bid was received and opened on March, 24, 2022. The one bid received was not from an MBE/WBE certified firm. Muñiz Concrete & Contracting, Inc. submitted the lowest responsive bid including two alternates of \$224,750.
