ELIGIBILITY REQUIREMENT: This written examination shall be held in accordance with the Agreement between the City of Austin and the Austin-Travis County EMS Employees Association and with Civil Service law and rules, and shall be open to each Medic-Field who at the time of the promotional examination has a current Texas Department of State Health Services certification as an Emergency Medical Technician-Paramedic or Licensed Paramedic <u>and</u> has cleared to independent duty.

It is the responsibility of candidates seeking education points to ensure that the Human Resource Division of the Department has the necessary supporting documentation for education points. The documentation must be received by the HR Division no later than 5:00 PM, October 11, 2022. No education points will be counted unless proper documentation is timely received.
