Posting Language

Authorize negotiation and execution of Amendment No. 12 to the agreement with Central Texas Food Bank, Inc. for food and Supplemental Nutrition Assistance Program services, to add two 12-month extension options each in an amount not to exceed \$299,843, for a revised total agreement amount not to exceed \$2,754,064.

Fiscal Note

Funding in the amount of \$299,843 is available in the Fiscal Year 2022-2023 Austin Public Health Department Operating Budget. Funding for the remaining terms is contingent upon available funding in future budgets.

Prior Council Action:

September 3, 2020 - Council authorized Amendment No. 10 to the agreement with Central Texas Food Bank, Inc., increasing funding in an amount not to exceed \$16,180 for the term ending September 30, 2020 and to add a fourth 12-month extension option in an amount not to exceed \$299,843, for a revised total agreement amount not to exceed \$2,154,378, on an 11-0 vote.

May 18, 2017 - Council authorized Amendment No. 5 to the agreement with Central Texas Food Bank, Inc., increasing the current agreement in an amount not to exceed \$88,246 for the contract period ending September 30, 2018, and increasing funding for the three remaining 12-month renewal options each in an amount not to exceed \$65,483, for a revised total agreement amount not to exceed \$1,748,603, on an 11-0 vote.

November 20, 2014 - City Council authorized award, negotiation, and execution of a 37-month agreement with Central Texas Food Bank, Inc., with three 12-month extension options, on a 6-0 vote, with Council Member Tovo recusing herself from contracts associated with Creative Action.

Approval of Amendment No. 12 will allow the continued provision of basic needs services, including food distribution and assistance with applying for the Supplemental Nutrition Assistance Program.

Amendment No 11 exercised the fourth extension option in the amount of \$299,843 for the period of October 1, 2021 to September 30, 2022.

Amendment No 10 added one-time funds of \$16,180 and exercised the third extension option in the

amount of \$299,843 for the period of October 1, 2020 to September 30, 2021 and added a fourth 12-month extension option in the amount \$299,843.

Amendment No 9 added one-time funds of \$58,000 and exercised the second extension option in the amount of \$299,843, for the period of October 1, 2019 to September 30, 2020.

Amendment No 8 exercised the first extension option in the amount of \$299,843 for the period of October 1, 2018 to September 30, 2019.

Amendment No 7 added funds in the amount of \$2,500 for the period of October 1, 2017 to September 30, 2018.

Amendment No 6 added a 2.5% cost of living increase in the amount of \$7,313.

Amendment No 5 added a 2.3% cost of living increase in the amount of \$88,246.

Amendment No 4 modified the program exhibits.

Amendment No 3 added one-time funding in the amount of \$43,626 for the period of October 1, 2016 to September 30, 2017.

Amendment No 2 added \$15,280 to the base agreement as a result of a 6% cost of living increase approved by Council for the period of October 1, 2015 to September 30, 2016.

Amendment No 1 added one-time funding in the amount of \$42,720 to the agreement for Fiscal Year 2015-2016.

The current social services agreement with Central Texas Food Bank, Inc was awarded from the Austin Public Health Department's Self-Sufficiency Request for Applications in Fiscal Year 2014-2015. Services began on September 1, 2015 for an initial 37-month term ending on September 30, 2018 in the amount of \$681,141, with three 12-month extension options each in the amount of \$227,047, with a total agreement amount not to exceed \$1,362,282.
