<u>SUBJECT:</u> Approve ratification of execution of change order #5 to the construction contract with SALAS CONSTRUCTORS, INC. (MBE - 74.74%), Buda, TX, for the Austin Clean Water Program South Congress Avenue Wastewater Project in the amount of \$143,033.23, for a total contract amount not to exceed \$876,365.23.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$143,033.23 is included in the Fiscal Year 2004-2005 Capital Budget of the Austin Water Utility.

PRIOR COUNCIL ACTION: The construction contract award for \$733,332 was approved on 1/29/04.

MBE / WBE: 12.06% MBE and 13.2% WBE subcontractor participation to date.

This project includes the installation of approximately 3,500 linear feet of 8-inch sanitary sewer including all the ancillary construction along South Congress Avenue, from south of Ben White Boulevard to just north of Williamson Creek. The project originally included the excavation and disposal of Class I and Class II contaminated soils at a regulated landfill. Actual site conditions resulted in an increase of Class I quantities and the elimination of all Class II quantities from the contract. This project is part of the Austin Water Utility's Austin Clean Water Program (ACWP), which was developed to respond to the requirements of the Environmental Protection Agency's Administrative Order regarding Sanitary Sewer Overflows. The contract identifies construction duration of 120 calendar days. The project is approximately 95% complete.

This change order provides for additional costs associated with utility conflicts that were not identified in the original design. Because a mutually agreeable amount could not be negotiated with the Contractor and in order to maintain progress on the project and minimize continued traffic impacts to the traveling public, this work was performed under a Change Directive. The dollar amount listed below reflects agreed amounts on Change Directive work based on records of actual labor, material and equipment. Although the cost escalation for this project has reached the 125% maximum allowed by statute, the work was continued and compensation for the balance of the work will be paid upon resolution of pending claims. A future request for Council authorization will address payment of those claims.


Subcontractor participation for work addressed herein is indeterminate pending resolution of claims between prime and subcontractors.
