The Department of Small & Minority Business Resources (DSMBR) is requesting authorization to extend the contract with Business Resource Consultants (BRC) through September 30, 2005. The contract was administratively awarded for a five-month period from October 1, 2004 through February 28, 2005. The extension will allow small business owners and entrepreneurs to continue receiving services without disruption, while allowing the City time to complete a Request For Proposal (RFP) process and establish new service contracts for the new service delivery model for small business development services.

DSMBR has been working with the Economic Growth and Redevelopment Services Office to implement the City Council's directive to develop a comprehensive strategy to deliver efficient and cost -effective services to small and minority business owners. This new service delivery model will be implemented through the new contracts that are awarded through the RFP process.

BRC provides technical assistance and training to small and minority businesses in the construction related industries with an emphasis on African–American firms. Examples of services include:

- o cost estimating assistance
- o legal services
- o development of marketing materials
- o information on bid opportunities
- training on construction related topics
- o maintaining a plans room
