**SUBJECT:** Authorize execution of a 12-month supply agreement with RDO EQUIPMENT CO., Pflugerville, TX, for captive repair parts for John Deere heavy equipment in an amount not to exceed \$65,000, with three 12-month extension options in an amount not to exceed \$65,000 per extension option, for a total agreement amount not to exceed \$260,000.

**AMOUNT & SOURCE OF FUNDING:** Funding in the amount of \$37,917 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Financial and Administrative Services Department, Fleet Fund. Funding for the remaining five months of the original contract period and extension options is contingent upon available funding in future budgets.

**FISCAL NOTE:** There is no unanticipated fiscal impact. A fiscal note is not required.

This contract establishes a reliable source for the supply of captive repair parts for the City's fleet of John Deere heavy equipment used by several City departments to dig, load, and move soil, sand or other types of loose bulk materials. Captive repair parts are parts supplied by the original manufacturer or by a dealer authorized by the original manufacturer to sell them. The majority of this heavy equipment consists of tractor/loader/backhoes manufactured by John Deere.

These parts will be purchased on an as needed basis for general routine and preventative maintenance repairs. This contract is necessary to supply the automotive and equipment fleet service centers with a reliable and continuous source of supply to purchase these parts.
