This contract will provide systems furniture for the relocation of Financial Services' Controller's, Purchasing, and Telecommunication and Regulatory Affairs Offices from a leased facility at II Commodore Plaza to the City-owned Municipal Building at 124 W. 8th Street. In addition to accommodating the increase in the number of employees to be located in the building, some of the new offices have numerous visitors and high traffic areas as well as extensive file storage needs. As a result, the office space in the building required re-configuration. This contract will provide for 60 modular offices at \$3,826 per station. All hard-wall offices will re-use existing free-standing furniture from the Municipal Building, Norwood Towers and II Commodore. To the extent possible, existing systems furniture will also be reused.

The projected move-in date is scheduled for April 2005. Delivery is estimated at six weeks, including two weeks for installation.

The local authorized dealer, Furniture Marketing Group, will provide and install the furniture for the manufacturer Haworth Inc. Haworth is under contract with the Texas Building and Procurement Commission (TBPC) to supply modular furniture statewide as a result of a competitive bidding process through TBPC.
