MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract will provide for the purchase of 60 Trek Police bicycles and accessories to be used by the Walking Beat Unit of the Downtown Area Command (DTAC) of the Austin Police Department. Currently, bikes are shared by several officers and are in use 24 hours per day, seven days per week. Due to the heavy usage, the bikes require frequent maintenance and repair. This results in significant downtime and a shortage of bikes for patrol. This purchase will provide a bike for each officer in Walking Beat. With this equipment, DTAC will be able to more effectively perform the patrol function and provide an increased police presence. The Trek Police bike is designed specifically for police use and comes with a life-time warranty on the frame. The bikes currently in use will be re-deployed to other area sectors, be stripped for parts, or sent to City Salvage for auction.
