<u>SUBJECT:</u> Authorize execution of a construction contract with SOUTHWEST CORPORATION, Austin, TX, for Health and Human Services Department (HHSD) Phase II - Building C Renovations for the Office of Vital Records in an amount not to exceed \$138,819.

The Office of Vital Records of the Health and Human Services Department (HHSD) is currently located in Cesar Chavez building at 1111 East Cesar Chavez. As part of an agreement made with the Hospital District of Travis County, all HHSD offices will be moved out of this building as soon as possible. The Office of Vital Records is a major component in this building.

HHSD will move the Office of Vital Records (OVR) into one of the buildings at a City of Austin owned campus, at 601 Airport Boulevard. Building C will be renovated to accommodate the functions of the OVR. The occupants of Building C have been relocated in order to complete construction in the building. This project consists of a new waiting lobby, a public restroom, conference rooms, archival storage, and offices for the staff of the OVR. Construction will be expedited.

The contract allows 60 calendar days for completion of this project.

Bid documents were distributed to 6 general contractors. Bids were opened on March 10, 2005. Southwest Corporation submitted the lower of 2 bids received:

The contractor's choice of work methodology provides for 12 areas of subcontracting opportunities: mechanical, drywall and ceilings, glazing, masonry, final cleaning, plumbing, electrical, fire protection, flooring, painting, roofing, and millwork.


