**AN ORDINANCE AUTHORIZING THE CITY'S CO-SPONSORSHIP OF THE 2005 AUSTIN FARMER'S MARKET; WAIVING CERTAIN FEES AND STREET CLOSURE REQUIREMENTS; AUTHORIZING IN-KIND CONTRIBUTIONS; AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The Council approves City co-sponsorship, including fee waivers and in-kind contributions for a total amount not to exceed \$25,319, for the 2005 Austin Farmer's Market, to be held each Saturday beginning on March 27, 2005, through October 29, 2005, at Republic Square Park in the City of Austin.

**PART 2.** The Council waives the following fees and charges to be paid by the Sustainable Food Center Austin Farmers' Market.

Sound Fee	\$ 1,023.00
Permit Fee	\$ 3,100.00
Safety Inspection Fee	\$ 2,356.00
Park Rental Fees	\$ 7,700.00
Mobile Vendor Permit Fee	\$ 90.00

**PART 3.** The Council authorizes the following in-kind contributions to the event:
