SUBJECT: Authorize execution of a construction contract with KEYSTONE CONSTRUCTION, INC., Austin, TX, for Anderson Hill Block A Subdivision Project for infrastructure improvements to support the future development of the ten new Smart Housing town homes in an amount not to exceed \$207,450.

AMOUNT & SOURCE OF FUNDING: Funding is available in Neighborhood Housing and Community Development Office (NHCD) HOME, Anderson Hill Redevelopment Program.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

On May 11, 2000, the City of Austin's Neighborhood Housing and Community Development Office (City) entered into a settlement agreement with the Anderson Community Development Corporation which transferred certain parcels along East 12th Street to the City and states that the City would develop up to fifty new housing units. The proposed alleyway and utility improvements will support the development of ten of these housing units on East 12th Street between Curve Street and Waller Street.

The work included in this project will provide for infrastructure (water, sewer, power, communication duct, and access alley) to support the future development of the ten new Smart Housing town homes. All new utilities will be underground. The contract allows 180 calendar days for completion of this project.

Bid documents were distributed to 2 general contractors. Bids were opened on February 10, 2005 Keystone Construction, Inc. submitted the lowest of 2 bids received:

Keystone Construction, Inc., Austin, TX	\$207,450.00
Smith Contracting Company, Inc., Austin, TX	\$211,400.00

The contractor's choice of work methodology provides for 7 areas of subcontracting opportunities: erosion control, hauling, trenching, photography, traffic control, asphalt repair, and concrete work.



Participation subgoals stated in the solicitation were 12.9% MBE; 12.6% WBE. Total participation estimated on bid amount of \$207,450.00.



66.90% Non M/WBE prime participation; 16.55% MBE; 16.55% WBE; 0.00% Non M/WBE subcontractor participation.




