Austin Energy is negotiating an agreement with Hotel Properties Austin, L.P., to provide chilled water-cooling services for the new Downtown Austin Marriott Hotel from Austin Energy's downtown district cooling system. To complete the interconnection between the district cooling system and a customer's building, Austin Energy owns and maintains individual heat exchanger(s) at the building. To expedite the design and construction of the heat exchanger(s) and associated piping for the Downtown Austin Marriott

exchanger(s) and to reimburse actual costs not to exceed \$128,000.

This RCA is to seek authorization for Austin Energy to complete the purchase of the heat exchanger(s) and piping once the installation is complete to the satisfaction of Austin Energy inspectors.
