ORDENANZA PARA ENMENDAR ADJUNTOS A, B, Y C DE LA ORDENANZA NO. 050217-04 QUE ORDENA LA ELECCIÓN MUNICIPAL GENERAL DEL 7 DE MAYO, 2005, PARA APROBAR CAMBIOS A SITIOS DE VOTACIÓN DEL DÍA DE ELECCIONES Y DE LA VOTACIÓN ADELANTADA Y A LA LISTA DE JUECES DE PRECINTOS DEL DÍA DE ELECCIONES; Y DECLARANDO UNA EMERGENCIA.

POR ORDEN DEL CONSEJO MUNICIPAL DE LA CIUDAD DE AUSTIN:

PARTE I. Los Adjuntos A, B, y C de la Ordenanza No. 050217-04, ordenando la Eleccion General Municipal el 7 de Mayo, 2005 se enmiendan para aprobar cambios a sitios de votacion el dia de elecciones, a la lista de jueces de precintos el dia de elecciones y a los sitios de la votacion adelantada, respectivamente, como se indica en los adjuntos incluidos.

AN ORDINANCE AMENDING EXHIBITS A, B, AND C OF ORDINANCE NO. 050217-04 CALLING THE MAY 7, 2005, GENERAL MUNICIPAL ELECTION TO ADOPT CHANGES TO ELECTION DAY AND EARLY VOTING POLLING LOCATIONS AND TO THE LIST OF ELECTION DAY PRECINCT JUDGES; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Exhibits A, B, and C of Ordinance No. 050217-04, calling the May 7, 2005, General Municipal Election, are amended to adopt changes to election day polling locations, the list of election day precinct judges, and early voting locations respectively as shown on the attached exhibits.

PART 2. The Council finds that the need to adopt and publish polling locations and the list of election precinct judges constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health, and safety.
