This contract establishes a service agreement with Prudential Overall Supply for weekly uniform service for approximately 316 employees of the Solid Waste Services Department. Each employee will be assigned eleven sets of uniforms. The Contractor will pickup and deliver the uniforms on a weekly basis. Employees in Operations Recycling-Refuse Collection, Facility Maintenance and Anti-Litter Street Cleaning-Brush/Bulky Collection divisions will be issued uniforms.

Solid Waste Services has a year-round need for uniforms. Employees at Solid Waste Services perform a number of tasks that soil and damage uniforms. This service will provide fitted, laundered, and pressed uniforms free of prominent stains and in good repair. Uniforms will be replaced at no additional cost when they are damaged or no longer fit properly.
