<u>SUBJECT:</u> Authorize execution of a 12-month supply agreement with NORSEMAN PLASTICS LTD, Rexdal, Ontario, Canada, for recycling bins for the Solid Waste Services Department in an amount not to exceed \$104,525, with two 12-month extension options in an amount not to exceed \$104,525 for each extension option, for a total contract amount not to exceed \$313,575.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$43,552 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Solid Waste Services Department. Funding for the remaining seven months of the original contract period and extension options is contingent upon available funding in future budgets.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract establishes a supply agreement for an estimated quantity of 25,100 curbside recycling bins to be issued to households for the Curbside Recycling Program in the Solid Waste Services Department.

These recycling bins are being purchased to accommodate the growth of the City to include enough in inventory for new annexations, replacement of damaged bins, continued implementation of the Pay-As-You-Throw Program and special re-distribution of bins to low participation areas. Research has revealed that areas of high rental turnover have a low participation in recycling due to the lack of bins available to new tenants. Re-distribution of bins to low participation areas increases recycling participation. It is important that the Solid Waste Services Department maintain an adequate recycling bin inventory in order to maximize recycling participation and subsequent avoidance of excess garbage charges for customers.
