SUBJECT: Ratify change order # 7 to the construction contract with TEXAS ROAD AND UTILITIES, INC., Buda, TX (WBE 67.90%) for the removal and replacement of 300 linear feet of wastewater line and paving repairs to a driveway for the Austin Clean Water Program: Westgate Area Wastewater Improvements Project in the amount of \$140,000, for a total contract amount not to exceed \$2,236,951.13.

The purpose of this Austin Clean Water Program project is to replace deteriorated and aging sanitary sewer lines in an area near West Gate Boulevard that were exhibiting excessive overflows. This project is part of the City's response to the current Administrative Order addressing Sanitary Sewer Overflows issued to the City of Austin by the U.S. Environmental Protection Agency.

The original work included installation of over 11,000 linear feet of wastewater pipeline from 8-inch to 18-inch diameter, associated appurtenances, and relocation of approximately 24 residential service connections. The contract specified 180 working days for substantial completion.

This change order provides for the addition of 200 linear feet of asphalt driveway replacement that was required by a special provision to an easement, but not indicated on the construction plans. It provides for the resolution of a claim for a portion of the contractor's cost to remove, and re-install at the proper elevation, 300 linear feet of 12-inch diameter wastewater line. It also provides compensation for the relocation of a water line in conflict with the alignment and grade of the new wastewater line.

This change order also provides for resolution of a pending contractor claim for changed soil conditions for the geotechnical borings for the project. The actual soils encountered were different than the contractor had anticipated, therefore more time and effort was spent installing the line. These soil condition changes occurred from 3500 Pack Saddle Pass to 5000 Pack Saddle Pass. The amount associated with this item is to cover potential settlement of this unresolved construction issue.

This memo is to provide you with further information concerning the ratification of a change order in the amount of \$140,000.00 with Texas Road and Utilities, Inc., for the ACWP West Gate Neighborhood Wastewater Project that is scheduled for the June 23, 2005 Council Agenda.

Previous change orders were for changes caused by utility conflicts, unforeseen conditions, and additional asphalt installation. These conditions became apparent immediately after excavation and were not readily apparent during the design and utility coordination phases of the project.

The current change order is also for changes caused by utility conflicts, unforeseen conditions, and correcting drainage issues. The change order work included additional asphalt to be laid for a driveway that also serves as a drainage easement, repairs made to existing utilities that had been incorrectly identified in the bid documents, correction for the wastewater line that was removed and re-installed to the proper elevation and to provide for a pending contractor claim for changed soil conditions for the geotechnical borings. The actual soils encountered were different than the contractor had anticipated, requiring the contractor to spend more time and effort for the installation.

In order to reduce the impact of construction on the neighborhood and traveling public, the contractor was directed to proceed with the changes, and that quantity adjustments would be made to his contract when additional authority was obtained. Stopping work after excavation would have delayed the end date of construction and incurred additional costs to the City for contractor overhead and re-mobilization. 100% of the work in the proposed change order has already been completed by the contractor.
