SUBJECT: Approve a resolution authorizing the filing of eminent domain proceedings for the Govalle 3-Carson Creek at Montopolis Drive Project, a portion of the Austin Clean Water Program, to acquire a 15,397 square foot permanent wastewater line easement, an 11,748 square foot permanent access easement, an 18,183 square foot temporary working space easement, and a 20,000 square foot temporary staging area and material storage site easement out of the Santiago Del Valle Grant, Abstract 24, City of Austin, Travis County, Texas, in the amount of \$43,700. The owner of the property interests sought to be condemned is Leigh Acres, Ltd., a Texas Limited Partnership. 
