<u>MBE / WBE:</u> This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore no goals were established for this solicitation.

This is a one-time purchase for radiation detection and gas monitoring equipment including a four-year maintenance agreement for the Austin Fire Department (AFD). It is the goal of this grant-funded program to acquire and place in service equipment to be used by AFD personnel to detect radiological particles / energy and / or gas agents. The equipment is used to identify flammable / combustible gases, and / or radiation that presents an unsafe working environment for emergency workers. Gases and / or radiation need to be identified by type and quantity, i.e., sites involving natural gas leaks, sewer line maintenance or any place where chemical are stored, such as warehouses, truck trailers or train cars.

The City of Austin has received funding from the 2004 Domestic Preparedness/TEEX (Texas Engineering Extension Service) state homeland security grant.
