SUBJECT: Approve an ordinance authorizing acceptance of \$1,500 in grant funds from the American Library Association Jewish Literature grant and amending Fiscal Year 2004-2005 Operating Budget Special Revenue Fund of Ordinance No. 040913-01 to appropriate \$1,500 to the Austin Public Library's Jewish literature project entitled "Let's Talk About It: Jewish Literature."

Let's Talk About It: Jewish Literature is a grant program supported by the American Library Association Public Programs Office. The Old Quarry Branch Library will hold five community book discussion groups centered on the selected theme of Your Heart's Desire, led by Dr. Helene Mevers, a local Jewish scholar. This theme was chosen because Dr. Meyers has done scholarly research on some of the authors and is familiar with the titles of books included for this theme. Each discussion will be about a different book but will follow the same format. Discussions will be held once a month between January and May 2006. Dr. Meyers will engage participants by asking provocative questions utilizing the curriculum provided by the American Library Association and her own knowledge. The Austin Public Library will appoint a Project Director who will attend a mandatory training session in order to implement and facilitate the program. Discussions will be publicized citywide.

The grant will fund the purchase of books for the discussion groups, publicity for the program, an honorarium for Dr. Helene Meyers, and travel expenses for the Austin Public Library Project Director to attend the mandatory training session in November 2005. Goals of the program are to expand the literary horizons of participants who may have an interest in, but not much knowledge about, Jewish literature, to enhance the Old Quarry Branch Library's collection of quality Jewish writers, and to increase adult participation in cultural library programs. The Library intends to collaborate with the Jewish Community Association of Austin (JCAA), the Austin Chapter of Hadassah, and the Austin Jewish Academy. The Old Quarry Branch Library's service area includes the largest percentage of Jewish residents in Austin.
