**SUBJECT:** Authorize execution of a 12-month service agreement with A-1 QUALITY BLUEPRINT & FAST COPY, Austin, TX for blueline printing services in an amount not to exceed \$104,253, with three 12-month extension options in an amount not to exceed \$104,253 per extension option, for a total agreement amount not to exceed \$417,012.

<u>AMOUNT & SOURCE OF FUNDING:</u> Funding in the amount of \$17,376 is available in the Fiscal Year 2004-2005 Approved Operating Budget of various City Departments. Funding for the remaining 10 months of the original contract period and extension options is contingent upon available funding in future budgets.

#### PRICE ANALYSIS

- a. Adequate competition.
- b. Sixteen notices were sent including three MBEs and three WBEs. Six bids were issued including three WBEs. Four bids were received, including two WBEs. The MBEs did not respond.
- c. The pricing proposed represents an approximately 8% increase from the last contract awarded in February 2002. The increase is in line with the overall increase in paper throughout the industry.
