

**SUBJECT:** Authorize execution of a 12-month supply agreement with AUSTIN WHITE LIME COMPANY, Austin, TX, for quicklime for the Austin Water Utility in an amount not to exceed \$743,185, with two 12-month extension options in an amount not to exceed \$743,185 per extension option, for a total contract amount not to exceed \$2,229,555.

**AMOUNT & SOURCE OF FUNDING:** Funding in the amount of \$185,797 is available in Fiscal Year 2004-2005 Approved Operating Budget of the Austin Water Utility. Funding for the remaining nine months of the original contract period and extension option is contingent upon available funding in future budgets.

**FISCAL NOTE:** There is no unanticipated fiscal impact. A fiscal note is not required.

The product complies with the American Water Works Association (AWWA) Standard B202-02, which is the standard for quicklime used for the treatment of drinking water. It also meets National Sanitation Foundation (NSF) Standard 60 which governs the use of direct and indirect additives for the treatment of drinking water.
