SUBJECT: Authorize the negotiation and execution of an agreement to purchase the wastewater treatment facilities and associated appurtenances from Dessau Utilities, Inc., in an amount not to exceed \$2,175,282, to provide wastewater service to customers in northeast Travis County.

Dessau Utilities, Inc. ("Dessau") is an investor owned wastewater utility. Dessau's service area, certificated by the Texas Commission on Environmental Quality, is located in the northeast portion of Travis County along Dessau Road. Approximately 800 customers reside within the service area. The City of Austin ("City") provides retail water service to the wastewater customers of Dessau. A majority of Dessau's service area is located within the corporate limits of the City of Austin. Dessau's wastewater treatment plant currently discharges into an unnamed tributary of Harris Branch Creek. The wastewater treatment plant is currently permitted at 500,000 gallons per day ("gpd") with an average daily flow of approximately 170,000 gpd.

Major points of the purchase agreement include:

- The agreed upon value of the wastewater facilities and associated appurtenances is \$2,175,282 and the City will pay that amount in cash;
- Dessau will complete construction, prior to the City actually acquiring the wastewater facilities, of a new lift station located at the Dessau wastewater treatment plant site to assist in providing service to the area; and
- The City will assume from Dessau those wastewater capacity service contracts that are still in full force and effect, which total approximately 865 wastewater service units of capacity.

The 30-year Net Present Value for the purchase is positive.




