SUBJECT: Authorize execution of a 12-month supply agreement with SIEMENS AIRFIELD SOLUTIONS, Columbus, OH for the purchase of replacement airfield lamps for the Austin-Bergstrom International Airport (ABIA) in an amount not to exceed \$61,172.80, with two 12-month extension options in an amount not to exceed \$61,172.80 per extension option, for a total contract amount not to exceed \$183,518.40.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$5,098 is available in the Fiscal Year 2004-2005 Approved Airport Operating Fund of the Department of Aviation. Funding for the remaining 11 months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: There is no unanticipated fiscal impact. A fiscal note is not required.

Included are lamps of various types and sizes for airfield light fixtures.
