<u>SUBJECT:</u> Authorize execution of a 12-month supply agreement with AIRGAS SPECIALTY PRODUCTS, Atlanta, GA, for the purchase of anhydrous ammonia for the Austin Water Utility in an amount not to exceed \$86,320, with two 12-month extension options in an amount not to exceed \$86,320 per extension option, for a total contract amount not to exceed \$258,960.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$7,193 is available in the Fiscal Year 2004-2005 Approved Operating Budget of the Austin Water Utility. Funding for the remaining 11 months of the original contract period and extension options is contingent upon available funding in future budgets.

**FISCAL NOTE:** There is no unanticipated fiscal impact. A fiscal note is not required.

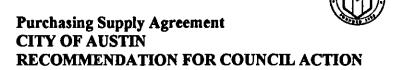
This contract establishes an annual supply agreement to provide anhydrous ammonia for the Austin Water Utility. Anhydrous ammonia is mixed into chlorinated water to form chloramines, the secondary disinfectant utilized in the potable drinking water treatment. The anhydrous ammonia will be delivered to and used at the water treatment plants. This product complies with the National Sanitation Foundation (NSF) Standard 60 which governs the use of direct and indirect additives for the treatment of drinking water.
