Communications and Technology Management would like to enter into an Interlocal Agreement with the University of Texas at Austin, Austin Technology Incubator (ATI) for two initiatives:

1. A test of Orthogonal Frequency Division Multiplexing (OFDM) wireless broadband technology WiMax which will support the City of Austin's ability to transfer wireless digital data.

ATI will perform a test of OFDM wireless broadband technology in a mobile environment. The test will involve the transmission of live video and audio over a wireless communication link between a vehicle and a base station. ATI has the only base station for this type of testing in Austin.

2. Investment in the development of a complete Strategy and Technology Battlefield Map being developed for the Digital Convergence Initiative.

The Digital Convergence Initiative (DCI) is a public/private venture to facilitate the growth of the digital-oriented industrial and scientific base of Central Texas. The Strategy and Technology Battlefield Map project will develop a technology strategy map for digital convergence together with an inventory of digital convergence companies in Central Texas. The companies' technologies/services/content will be located in the technology map. This step will enable DCI to identify economic development opportunities that are not visible now because we cannot establish
