<u>SUBJECT:</u> Approve a resolution authorizing an application for grant funding to the U.S. Department of Justice, Office of Justice Programs, Community Capacity Development Office, Operation Weed and Seed in the amount of \$175,000 in grant funds for the Central East Austin Weed and Seed Program for law enforcement, crime prevention and community revitalization.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$175,000 is available in the grant period October 1, 2005 - September 30, 2006 from the U.S. Department of Justice, Office of Justice Programs, Community Capacity Development Office. This is the first year of a five-year grant. No cash match is required.

This action approves a resolution authorizing the City of Austin, Austin Police Department, to apply for \$175,000 in first year grant funding from the U.S. Department of Justice, Office of Justice Programs. Community Capacity Development Office, Operation Weed and Seed. Operation Weed and Seed is a program that incorporates community-based initiatives into a comprehensive multi-agency approach to law enforcement, crime prevention, and community revitalization. The Central East Austin Weed and Seed Program was given Official Recognition by the U.S. Department of Justice on June 1, 2005. This formal recognition allows the City of Austin to apply for grant funding for a five-year period.

Operation Weed and Seed is designed to promote collaboration among residents, law enforcement, government officials, prosecutors, schools, local businesses, churches/synagogues and social service providers to "weed out" violent crime, gang activity and drugs in a designated community and "seed in" coordinated social services, economic revitalization and neighborhood restoration.

The funding, which is required to be divided evenly between "weeding" and "seeding" operations, will be distributed as follows:

Weeding (\$87,500)

- 1. \$63,000 Personnel (overtime to conduct special sting operations and law enforcement activities)
- 2. \$3,500 Travel (to Weed and Seed conferences and training)
- 3. \$4,500 Equipment (2 laptop computers)
- 4. \$6,500 Supplies (promotional materials and food costs for events, developing and printing
