The Austin Independent School District (AISD) is seeking approval to construct an approximately 35,000 square foot classroom and library addition on parkland at Kealing Park in which the District has an undivided 25% joint interest.

This construction project requires approximately 59,949 square feet, which is 9.16% of the park tract. Use of this location will require the District to relocate the current tennis courts which are located on the shared parkland to the west of the existing classrooms. Three courts are to be located on the Kealing site to the west of the additions and one is to be relocated to a site to be designated by the Parks and Recreation Department. Upon completion of the addition, scheduled for the fall of 2007, AISD would remove the existing portable classrooms currently covered in a six year license agreement with the City scheduled to expire in 2010. The additional parking required for the classroom expansion will be located on AISD property at the western end of the Kealing building. The additional parking spaces will be shared with the City and the access to those spaces is already in place.
