**SUBJECT:** Authorize acceptance of grant funds from the Department of Justice, Office of Victims of Crime, in the amount of \$75,000 for to develop a comprehensive public awareness campaign to raise awareness of victims' rights and services within the Spanish-speaking community in Austin and Travis County; and amend the Fiscal Year 2005-2006 Police Department Operating Budget Special Revenue Fund of Ordinance No.20050912-001 to appropriate \$75,000.

This action authorizes the City to accept \$75,000 in grant funding from the Department of Justice, Office of Victims of Crime. The grant period runs from October 1, 2005 to September 30, 2006. A match is not required for this grant. This grant funding will assist a very viable and active collaboration operation in Austin, Travis County to develop a specialized outreach message for underserved Spanish-speaking residents, many of whom have recently immigrated to the United States. The City of Austin, Police Department, Victim Services Division and Immigrant Protection Team, the Catholic Charities of Central Texas, the Political Asylum Project of Austin (Proyecto de Asilo Politico de Austin), SafePlace, Refugee Services of Texas, Inc., and the Center for Child Protection have joined in a collaboration. Grant funding will be used to plan and develop a comprehensive public awareness campaign to raise the awareness of victims' rights and services within the Spanish-speaking community in Austin, Travis County.

Funding will support a contract for social ministries trainings for victim rights issues; public service announcements with Spanish-speaking media; and supplies and printing costs for the outreach message. This grant addresses the Department goal of reducing crime, fear of crime, and improving the quality of life of Austin's residents.
