This action approves an ordinance authorizing the City to apply for and accept \$112,809 in grant funding from the U.S. Department of Justice, National Institute of Justice, Fiscal Year 2005 DNA Capacity Enhancement program. The grant period runs from October 1, 2005 through September 30, 2006.

Funding will be used to support the purchase of a walk-in freezer and monitoring equipment for the DNA and Evidence Sections, so that biological freezers will be continuously monitored and responsible parties will be notified as soon as a problem is identified. This will prevent the loss of valuable evidence due to a mechanical failure. This grant will also be used to purchase personal digital assistants (PDAs). This grant addresses the Department goal to improve efficiency through technology in order to provide information for daily operations, analysis and strategic planning and to increase the likelihood of successful prosecution of criminals.
