**ORDINANCE NO.**

**AN ORDINANCE WAIVING THE SECURITY DEPOSIT REQUIREMENT IN SECTION 14-8-12 AND THE SIGNATURE REQUIREMENT IN SECTIONS 14-8-16 AND 14-8-17 OF THE CITY CODE, WAIVING AND REIMBURSING CERTAIN FEES, AND AUTHORIZING THE PAYMENT OF CERTAIN EXPENSES IN CONNECTION WITH THE AUSTIN MILITARY SERVICE COALITION'S VETERAN'S DAY PARADE TO BE HELD ON NOVEMBER 11, 2005.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The Council waives the security deposit requirement in Code Section 14-8-12 (*Security Deposit Required*) and the signature requirement in Code Sections 14-8-16 (*Notice of Proposed Closure and Signature Requirement*) and 14-8-17 (*Calculation of Required Signatures; Request for Reduction*) for the Austin Military Service Coalition's Veteran's Day Parade (Veteran's Day Parade) to be held on November 11, 2005.

**PART 2.** The Council waives the following fees and charges in connection with the Veteran's Day Parade. Fees that have been paid shall be reimbursed.

Permit Fee	\$1,500.00
Sound Amplification	\$33.00
Application Fee	\$100.00

**PART 3.** The Council authorizes payment of the following expenses for the Veteran's Day Parade.

Barricade Costs	\$2,200.00
Street Sweeping	\$500.00
Police Officers	\$4,176.80
