<u>SUBJECT:</u> Authorize execution of a contract with AVW-TELAV AUDIO VISUAL SOLUTIONS, Austin, Texas for the purchase, delivery, and installation of rigging, lighting and sound equipment for the Austin Convention Center, Exhibit Hall 5, in an amount not to exceed \$324,838.

PURCHASING: One bid received.

MBE / WBE: This contact will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract is for the purchase, delivery, and installation of rigging, lighting and sound equipment for the Austin Convention Center (ACC), Exhibit Hall 5. The ACC will host a full season of home games for the Austin Toros, a new team in the National Basketball Association Development League. The equipment will be installed in a semi-permanent installation that will support the season of basketball games, and other events to be determined by the Austin Convention Center Department. The equipment will provide a minimum of 200 footcandles of light on the basketball court and a sound array that will provide quality sound for a minimum of 4,000 attendees. In additional, this upgrade will improve the capabilities to allow for theatrical productions, music events and other presentations.

The total price of \$324,838 includes these itemized costs: \$275,784 for the equipment and installation required labor for the systems with one-year manufacturer's warranties; \$33,094 for two additional warranty years on all equipment items; and \$15,960 for rental of some components for two weeks, plus labor costs for set up, if needed. The first basketball game is expected to be held on November 26, 2005 at the ACC. The solicitation requested vendors to provide costs for temporary equipment systems due to anticipated long delivery lead times required for some of the equipment items.

AVW-TELAV Audio Visual Solutions indicated that the majority of the components will be available for delivery prior to the first game with the exception of the amplifiers for the sound system and the dimmers and controllers for the lighting system requiring possible rental costs for the period as estimated above.
