The vision for the new City Hall and Second Street Retail District is to enhance the identity and image of downtown Austin as a civic and cultural destination for residents, visitors and businesses while preserving and enlivening Austin's unique sense of place. The "Great Streets" streetscapes for this area are well underway and include wide sidewalks with shade trees. To complete the vision, benches will we purchased and installed on CSC's Blocks 2 and 4 and AMLI Residential's Block 20 to enliven the pedestrian experience and support the public domain.

The Landscape Forms "Plainwell" benches, designed by native Austin resident Robert Chipman, have been installed through the Great Streets Program at the Hilton Hotel, Frost Bank Tower and Colonial Bank projects. Additional Landscape Forms Plainwell benches will be installed at the Plaza Lofts, 404 Rio Grande Apartments and as part of the second phase of Second Street District Streetscape Improvement Project from Colorado to Trinity Street at the Convention Center.

This agreement is entered into under the provision of the Interlocal Cooperation Act, Chapter 791, Texas Government Code.
