The Director of Human Resources requests the following changes in the Personnel Policies

## Chapter A, Section III.B.1a(1) and Chapter B, Section III.B.1a(1):

Change the policy to observe an official City holiday on Christmas Eve every year, instead of observing it as an official City holiday only when it occurs on Monday through Thursday, as currently provided This recommendation was made by the City Manager's Employec Committee on Workforce Issues as a benefit that would be enjoyed by all employees, beginning with this fiscal year when Chnstmas Eve, December 24 , falls on a Saturday

The Director of Human Resources recommends this change in order to provide two oflicial City holidays in December

WHEREAS, the Director of Human Resources has rccommended the following amendment of the Personnel Policies, and

WHEREAS, the City Manager approves and recommends adoption of this amendment, NOW, THEREFORE,

## BE IT RESOLVED BY THE CITY COUNCIL OF TIIE CITY OF AUSTIN:

That the City of Austın Personnel Policies be, and the same is hereby amended to provide for an additional holiday.

PART 1. That Chapter A, Section III B 1 a(1), Holidays, be revised as follows
(1) Holdays

The following holidays are declared official holidays for City employees If a holiday falls on Saturday, it will be observed on the preceding Friday, if a holday falls on Sunday, it will be observed on the following Monday, subject to the specific provisions below for the Christmas Eve and Christmas Day holidays

- If December 24 falls on a Sunday and December 25 falls on a Monday, then the Christmas Eve holiday will be observed on Monday, December 25 and the Christmas Day holiday will be observed on Tuesday, December 26

PART 2. That Chapter B, Section III.B $1 \mathrm{a}(1)$, Holdays, be revised as follows (1) Holdays

The following holidays are declared official holidays for City employees If a holiday falls on Saturday, it will be observed on the preceding Friday, if a holday falls on Sunday, it will be observed on the following Monday, subject to the specific provisions below for the Christmas Eve and Christmas Day holidays
