SUBJECT: Approve a resolution authorizing the filing of eminent domain proceedings for the Govalle 1-West of Lamar Project, a portion of the Austin Clean Water Program, to acquire a 750 square foot permanent wastewater line easement and a 624 square foot temporary working space easement out of Lot 7, Block Two, Barton Hollow, a subdivision in Travis County, in the amount of \$10,798. The owner of the needed property interests is Jane Eva Bullard, Austin, Texas. The property is located at 1206 Hollow Creek Drive, Austin, Travis County, Texas.

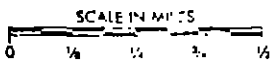
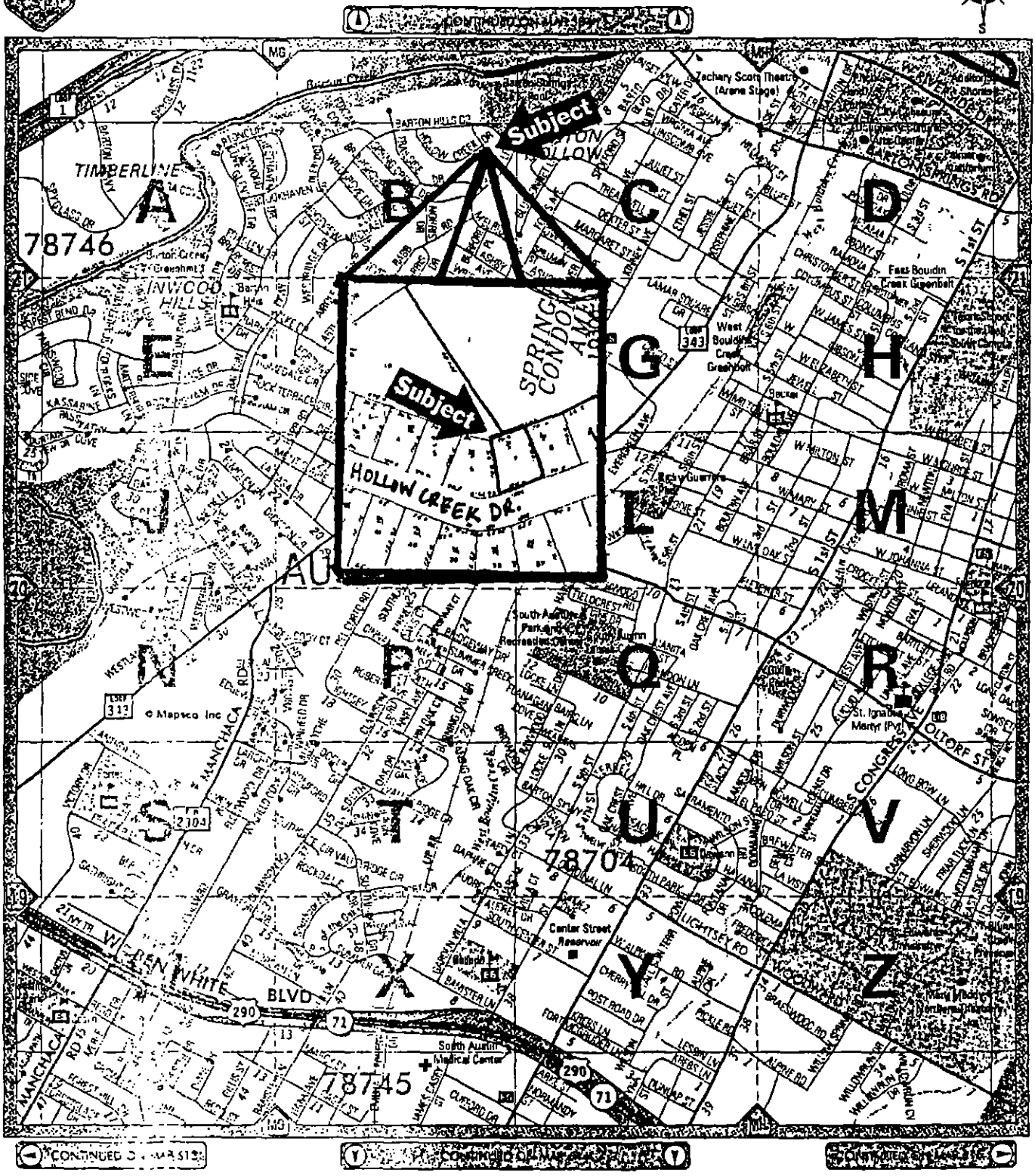

The design plans for the Govalle 1-West of Lamar Project, a portion of the Austin Clean Water program, require acquisition of a permanent wastewater line easement and a temporary working space easement on the property located at 1206 Hollow Creek Drive, Austin, Travis County, Texas.

The City of Austin has attempted to purchase the permanent wastewater line easement and the temporary working space easement from the landowner. However, the parties have been unable to agree on an appropriate price. The Law Department is requesting authorization to file a lawsuit in eminent domain on behalf of the City of Austin.



WIIEREAS, the City of Austin has attempted to purchase those needed real property interests but has been unable to agree with the owner on the fair market value thereof, **NOW, THEREFORE,**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the City Attorney, or other authorized designee, is hereby authorized and directed to file, or cause to be filed, a suit in eminent domain on behalf of the City of Austin against the owner now having, or who may acquire, an interest in the real property interests needed by the City, described and located below, for the public purposes set out below, and to take whatever other action may be deemed appropriate to economically effect the needed acquisitions
