SUBJECT: Authorize execution of a 12-month service agreement with LOOMIS FARGO & CO, Austin, TX, for armored car services in an amount not to exceed \$63,840, with two 12-month extension options in an amount not to exceed \$63,840 per extension option, for a total agreement amount not to exceed \$191,520.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$58,520 is available in the Fiscal Year 2005-2006 Approved Operating Budgets of various City departments. Funding for the remaining one month of the original contract period and the extension options is contingent upon available funding in future budgets.
