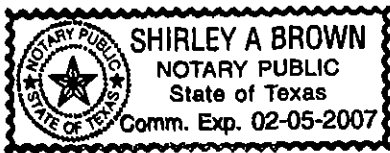

Your first degree relatives by affinity (marriage) are your spouse, your spouse's children, and your children's and parent's spouses. Your second degree relatives by consanguinity are your brothers, sisters, grandparents, and grandchildren. Your second degree relatives by affinity are your spouse's brothers, sisters, grandparents, and grandchildren, and the spouses of your brothers, sisters, grandparents, and grandchildren. For this purpose, a marriage that has ended because of death or divorce is considered to continue as long as a child of that marriage is living.
