Resolved by the City Council of the City of Austin ,Texas :

That, to correct said assessment against the above described property in the amount of five hundred (\$ 500.00 ) dollars, the same be and is hereby cancelled and annulled and both the owner of said property and the Assessor & Collector declared to be entitled to take credit on the assessment rolls of this City in accordance with the provisions of this resolution .
