4 CERTAIN FEES, AND AUTHORIZING THE PAYMENT OF EXPENSES IN
5 CONNECTION THE SUSTAINABLE FOOD CENTER'S 2006 AUSTIN
6 FARMER'S MARKET, A CITY CO-SPONSORED EVENT, FOR THE PERIOD
7 OF JANUARY 1, 2006 THROUGH DECEMBER 31, 2006.

9 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

16 Center's 2006 Austin Farmer's Market (Austin Farmer's Market) for the period of
17 January 1, 2006 though December 31, 2006.
