<u>SUBJECT:</u> Approve an ordinance authorizing the acceptance of \$75,000 in grant funds from the ROBERT WOOD JOHNSON FOUNDATION, Princeton, NJ, and amending the Fiscal Year 2005-2006 Health and Human Services Department Operating Budget Special Revenue Fund of Ordinance No. 20050912-001, to appropriate \$75,000 for the Health Promotion/Disease Prevention Unit to create an infrastructure and long-term strategic plan to explore opportunities for improving patient care and public health through the interactive exchange of health information between the local health department and community stakeholders.

<u>AMOUNT & SOURCE OF FUNDING</u>: Funding in the amount of \$75,000 is available from the Robert Wood Johnson Foundation. The grant period is from December 1, 2005 through November 31, 2006. No City match is required.

# Background

The purpose of this RCA is to accept \$75,000 in grant funds from Robert Wood Johnson Foundation. Improved access to, and use of, existing data would facilitate chronic and infectious disease as well as intentional and unintentional injury surveillance information-sharing, and would improve methods for reporting data to the local health department as mandated by local, state, and federal regulations. In addition, more integrated sharing of data could lead to improvements in timeliness and accuracy of data which could in turn lead to more rapid and effective response to public health emergencies such as disease outbreaks or tracking of current community health issues. Furthermore, improved data sharing between the local health department and local health care providers and organizations would allow for the integration of pertinent information into the clinical decision-making process, strengthen the collaborative relationship between public health and private health care providers, and ultimately improve community health while using scarce resources more efficiently and effectively. After the completion of the proposed project, the desired outcome would be the implementation of a shared vision for the exchange of individual- and population-level data to better inform clinical decision-making, educate the public regarding health status indicators, improve the quality of health services, increase access to health care services, and improve public health response and interventions. This project would support at a minimum the following department goals:

• Maintain a public health emergency preparedness plan in coordination with other city departments and community partners

- Identify, review and prepare report that describes current health care information exchange processes and practices by health providers, including public and private health entities, in Austin and other major Texas cities, and review existing best practices and models for health information exchange networks.
- Complete strategic planning sessions.

- Define possible technical solutions to optimize current systems, implement new systems, or integrate existing systems with new systems in general and specifically for immunization system improvements.
- Submit immunization stakeholder conference report to state and stakeholders/participants.
- Determine feasibility of a pilot project to improve data reporting among health providers.
