This proposed project will install approximately 300 feet of stream stabilization to cover and protect an exposed 36-inch wastewater line in Country Club Creek at its crossing with Grove Boulevard at the southernmost boundary of Roy Guerrero Park. The improvements will eliminate the risk of failure of an exposed 36-inch wastewater line, which would result in a major overflow in the creek. This project was developed as part of the Austin Clean Water Program (ACWP) effort to respond to the requirements of the Environmental Protection Agency's Administrative Order regarding Sanitary Sewer Overflows.

There will be no wastewater line replacement in this project. The work will consist of stream stabilization. All work will occur within Country Club Creek and within City of Austin park property. Coordination with the City of Austin Parks and Recreation Department occurred during design and will continue through construction. A small portion of the park will be impacted and full use of the park facilities will continue during construction.

The contract allows 150 working days for completion of this project.

Bid documents were distributed to 10 general contractors. Bids were opened on September 29, 2005. Facilities Rehabilitation, Inc. (MBE) submitted the lowest of four bids received:


