<u>SUBJECT:</u> Authorize execution of a construction contract with McLEAN CONSTRUCTION, LTD., Killeen, TX, for Del Valle Service to Annexed Area 3B in an amount not to exceed \$184,307.

**PURCHASING:** Lowest bid of four received.

MBE / WBE: 14.20% MBE and 3.52% WBE subcontractor participation.

The Del Valle Annexation Area, an area of approximately 1,200 acres, was annexed for Limited Purposes in September 1999 and for Full Purpose in September 2001. State Law mandates that construction of water and wastewater infrastructure begins within two years of the annexation and be completed within four and one half years of annexation. The Water and Wastewater Service Area Master Plan identifies the infrastructure required to provide a water distribution system, including adequate water service for fire protection, and a wastewater collection system for the area.

Recently, a subset of Area 3 was deducted and renamed as Area 3B. This work requires a short crossing at Carson Creek near the existing lift station with substantial stream bank stabilization to protect the line due to recent erosion in the area. Since this segment is at the downstream end of one of the smaller wastewater segments in Area 3, none of the property owners upstream of this work may receive wastewater service until the wastewater work in project Area 3B is completed. However, all of the remaining wastewater services in Area 3 are scheduled to be available for connection this winter.

The Work of this Contract comprises the construction of approximately 220 linear feet of 12-inch diameter wastewater line with 70 linear feet of 20-inch steel casing and approximately 150 linear feet of 16-inch diameter water lines, one wastewater manhole, five major wastewater manhole adjustments, one wastewater service and other appurtenances. This project also includes restoration of existing vegetation as shown on the construction drawings. The contract allows 105 calendar days for final completion of this project.

Bid documents were distributed to eight general contractors. Bids were opened on November 3, 2005. McLean Construction, Ltd. submitted the lowest of four bids received:

The contractor's choice of work methodology provides for four areas of subcontracting opportunities: water construction, sewer construction, coatings and material supplier.


