Council approved a Settlement Agreement with John S. Lloyd and the Bunny Bend Condominium Unit Owner's Association, Inc. on May 27, 2004. The Settlement Agreement required that not less than 23.62 percent of the Bunny Bend Condominium site be retained in its natural state to serve as a buffer zone. A map of the buffer zone was attached to the Settlement Agreement. This ordinance will accommodate the Bunny Bend Condominium Unit Owners request for a change in the buffer zone map. The amount of land dedicated remains at 23.62 percent and is of equal environmental value.

AN ORDINANCE AMENDING ORDINANCE NO. 040527-72 TO AMEND THE SETTLEMENT AGREEMENT WITH JOHN S. LLOYD AND THE BUNNY BEND CONDOMINIUM UNIT OWNER'S ASSOCIATION, INC.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Part 1, Exhibit "A" of Ordinance No. 040527-72 is amended by replacing the buffer zone map attached to the Settlement Agreement with the map attached to this ordinance as Exhibit "A". All other terms and conditions in the Settlement Agreement remain intact.

PART 2. This ordinance takes effect after the Bunny Bend Condominium Unit Owner's Association, Inc. modifies its Rule Regarding Buffer Area, required under Section 3 of the Settlement Agreement, to replace the buffer zone map attached to the rule with the map attached to this ordinance as Exhibit "A".
