The target age range for Youth served is 10 - 17 years. Youth under age 6 are not eligible for CYD. Youth served from ages 6-9 cannot exceed 30% of the Performance Measure for annual unduplicated Youth served. It is required that programs be provided in the afterschool hours? If a mentoring program is provided during school hours, is that eligible?	The description in the RFA application was not correct. Programs can be offered in school or out of school, including mentoring. However, is a program is primarily offered during school hours, applicants need to ensure that there is a plan in place for out of school time programming during the summer months (June-August) to ensure compliance with contract requirements.
In the pre-bid meeting, a goal of 1200 youth served was mentioned. Is 1200 the goal for this particular grant with DFPS or is 1200 an overall goal for the total number of youth served through all APH grant programs together?	1200 youth served is the annual target goal for the City of Austin's grant with the Department of Family and Protective Services. This target goal will be met by the Austin Public Health's direct service programs and through the services proposed and awarded through this RFA. Each service has a minimum threshold of outcomes and outputs that applicants must meet.
Are the Annual Outcome numbers provided on page 8-9 of the RFA Application required goals for each type of program service?	Yes, each service has a different outcome target.
I noticed that on page 3 of form C- RFA Scope of Work the Bonus Questions do not add up, they total to 9 Bonus Points. Will it be 9 or 10? If 10, where will the additional point be added?	The bonus questions are worth 10 points. The additional point will be added to the Mother- Friendly Workplace healthy service delivery.
Are the annual outcome targets listed under Section 2: Project Work Plan for each agency applying, or the overall goals across all funded agencies? In other words, can we propose lower outcome targets than what's listed there?	Some of the outcome targets listed in Section 2 are negotiable for a lower outcome target. Please refer to the Output and Outcome table on page 12 to view what targets are negotiable.
Is matching required to apply, and if we are able to find a match is that seen as positive or negative?	There is no match requirement for this funding opportunity. If applicants would like to provide that information there is a section in Budget Form 2030 to include match information. There are no points allocated to the match, however it gives us an idea of the true cost of the program or service.
Do we need to fill out the standard boilerplate agreement preemptively?	You do not need to fill out the standard boilerplate agreement preemptively, this will be done once the City of Austin is in negotiations with the top candidate(s).
I recently came across "11515-RFA 9100 CG0001 Community Youth Development 2021" and planned to submit an application for the July 8th deadline. However, we double checked the RFA details and realized the pre-application threshold has already passed. Is there a way for us to submit the pre-application?	The pre-application threshold deadline has passed and we are unable to accept applications that did not meet that deadline. Can our program include asynchronous and/or virtual synchronous components? If so, if a virtual workshop serves students while they are on-site at Akins or Travis, does it fulfill the on-site requirement? Can services be rendered during the school day or must it be after school? Since these campuses include students from other ZIP codes, would only 78744 students within these schools eligible to participate in our offerings?	Services can be during the school day or afterschool. 78744 students count towards the total amount. Each subcontractor is allowed to serve 30% of youth that do not live or go to school in 78744. Those students at the schools will be able to count under the 30% rule for the subcontractor. The CYD program will be following guidelines provided by the schools regarding in person and virtual learning. The goal of programming is to be engaged with the youth in the community so asynchronous programming is not preferred to be done since youth will not be able to form relationships with staff in a real time experience.

Principles of Service Delivery The services will have a goal of providing early intervention or prevention of at-risk behavior that leads to child abuse or neglect, delinquency, running away, and truancy. Individual Self- Esteem/Efficacy d. Positive Peer Association e. Community Involvement Must all five protective factors be addressed in the grant? What if a program directly affects 3 or 4 factors and indirectly impacts 1 or 2 (family bonding/communities, community involvement)?	No. Services do not need to include all 5 protective factors.
