CLAIMS BACK-UP DOCUMENTATION

WHAT IS REQUIRED:

The Grantee is required by the agreement to upload documentation to support expenses in the *Claim Supporting Documentation* section in PartnerGrants. The report must be run for only City of Austin charges and include:

- Charge period dates
- Accounting Codes and Account Titles for sections
- Itemized line items and transaction descriptions
- Charge and Credit columns
- Transaction totals

Throughout the program period, the Contract Manager can and will request more details supporting documentation. Examples include, but are not limited to:

- Profit & Loss Detail report from the Grantee's financial management system
- Check ledger from the Grantee's financial management system
- · Payroll reports and summaries, including salary allocation reports and signed timesheets
- · Receipts and invoices
- Copies of checks and bank statements showing transactions as cleared

ALLOWABLE EXPENSES

Expenses and/or expenditures shall be considered reimbursable only if incurred during the current Program Period, directly and specifically in the performance of the agreement, and in conformance with the agreement exhibits. Payment by the City is made on a reimbursement basis only; the grantee must have incurred and paid costs prior to those costs being invoiced.

The expenditures should have been incurred and paid within the month they are seeking reimbursement or incurred in the previous month and paid in the month from which they are seeking reimbursement.

The City can only reimburse for expenses that are allowable. This refers to whether the items being purchased are allowed under the agreement in the Program Budget & Narrative. Capital equipment items must be pre-approved by written authorization. See Exhibit B.3: Compensation Terms in the agreement boilerplate for a detailed summary of allowable, allowable with prior written authorization, and unallowable expenses.
