- ✓ Print the Application
- Check the box next to Acknowledgment Statement and sign the application. The application MUST be signed by the owner(s) listed on the Appraisal District's Records and the owner's agent, if applicable.
- ✓ Submit a Check or Money Order payable to the City of Austin for \$643.00 (to pay for the \$591 Application Fee, the \$50 Notification Fee and the \$2 DSD Technology Fee). Fees are non-refundable.
