## **2018 City Council District 3 Candidate Statement Transcripts**

>> HELLO.

I'M SUSANA ALMANZA, YOUR CANDIDATE FOR CITY COUNCIL DISTRICT 3.

I'M A FOUNDING MEMBER AND DIRECTOR OF PODER, AN ENVIRONMENTAL SOCIAL JUSTICE ORGANIZATION THAT HAS BEEN AROUND FOR OVER 25 YEARS.

I'M A NATIVE OF EAST AUSTIN AND A LONG TIME COMMUNITY ORGANIZER, EDUCATOR, MOTHER, AND GRANDMOTHER.

TOGETHER WE WILL WORK TO PRESERVE AND PROTECT NEIGHBORHOODS' AND SMALL BUSINESSES' UNIQUE CHARACTER, WHEREAS SABINO PIO RENTERIA HAS A LEGACY OF DISPLACING FAMILIES AND DESTROYING NEIGHBORHOODS.

IN 1928 THE CITY COUNCIL ADOPTED THEIR MASTER PLAN THAT FORCED THE RELOCATION OF PEOPLE OF COLOR TO EAST AUSTIN.

IN THE 1930s AND '40S, PEOPLE OF COLOR BOUGHT AND BUILT THEIR HOMES FROM 2,000 TO \$8,000.

THOSE PROPERTIES ARE NOW VALUED FROM 250,000 AND ABOVE.

**HOW DID THIS HAPPEN?** 

IN THE LATE 1990s THE CITY COUNCIL DECIDED THAT IT WOULD EMBARK ON A NEIGHBORHOOD PLANNING PROCESS.

ONE NEIGHBORHOOD FROM WEST AND EAST AUSTIN WOULD BE CHOSEN.

WE THEN BEGAN TO ORGANIZE TO SUBMIT A PLAN ON BEHALF OF EAST AUSTIN.

FIVE NEIGHBORHOODS CAME TOGETHER TO FORM THE PUEBLO NETWORK: BLACKSHEAR, MONTOPOLIS, GUADALUPE, EAST CESAR CHAVEZ AND RAINEY STREET.

AT THE DEADLINE FOR SUBMISSIONS, EAST CESAR CHAVEZ NEIGHBORHOOD, LED BY PIO AND LORI RENTERIA, SUBMITTED THEIR PLAN AS A SEPARATE APPLICATION.

THE PUEBLO NETWORK DIDN'T KNOW THAT PIO AND LORI RENTERIA WERE SECRETLY MEETING WITH CITY STAFF AND DEVELOPERS AND HAD MADE A DEAL.

FOR OVER A YEAR NEIGHBORHOOD LEADERS AND RESIDENTS FOUGHT AGAINST THE EAST CESAR CHAVEZ PLAN, STATING THAT IT WOULD CAUSE MAJOR DISPLACEMENT OF LONG TIME RESIDENTS IN GENTRIFIED NEIGHBORHOODS.

PIO AND LORI RENTERIA CAUSED THE DISPLACEMENT OF HUNDREDS OF RESIDENTS, THE ELDERLY STUDENTS, AND FAMILIES.

THEY SUPPORTED THE FIRST HIGH PRICED CONDOS IN THE EAST CESAR CHAVEZ NEIGHBORHOOD, WHILE RESIDENTS PROTESTED.

LET'S MOVE FORWARD TO 2015.

COUNCILMAN SABINO PIO RENTERIA BEGAN TO ADVOCATE FOR HIGH DENSITY DEVELOPMENT AND CODENEXT, STATING THAT HIGH DENSITY MEANT AFFORDABILITY.

AFFORDABLE FOR WHO?

THERE IS NO EVIDENCE OF THIS CREATING AFFORDABILITY.

AGAIN, PIO HAS A LEGACY OF DISPLACING RESIDENTS. COUNCILMAN PIO REFUSED TO LISTEN TO THE RESIDENTS REGARDING CODENEXT.

SO WE HAVE GATHERED THE 31,000 SIGNATURES TO PUT CODENEXT ON THE BALLOT.

COUNCILMAN PIO VOTED AGAINST PUTTING A VALIDATED PETITION ON THE BALLOT, AND WE HAD TO TAKE THE CITY TO COURT.

THE JUDGE RULED THAT CODENEXT INITIATIVE MUST BE PUT ON THE BALLOT.

DEMOCRACY WON.

CODENEXT DIDN'T RESPECT NEIGHBORHOOD PLANS, PUBLIC PARTICIPATION, AND WOULD HAVE INCREASED PROPERTY TAXES AND RENTAL PRICES.

IT WOULD MEAN MORE DISPLACEMENT.

WHERE DO WE GO FROM HERE?

WE MUST VOTE FOR PROPOSITION J, WHICH GIVE RESIDENTS A CHOICE TO APPROVE OR DISPROVE ANY PLAN LIKE CODENEXT AT THE BALLOT.

REFOCUS ON THE MOST IMPORTANT ASPECTS OF LAND CODE.

PRIORITIZE THE NEEDS OF CURRENT RESIDENTS AND DISCOURAGE THEIR DISPLACEMENT.

PRESERVATION AND CONSTRUCTION OF TRULY AFFORDABLE AND LOW INCOME HOUSING.

STREAMLINE AND UPDATE TECHNOLOGY OF CITY'S INEFFICIENT PERMITTING PROCESS.

AND RETURN THE COMMUNITY PLANNING DISTRICT.

IMPLEMENT THE PEOPLE'S PLAN, WHICH ADDRESSES HOUSING, ENVIRONMENT, AND EQUITY.

LET'S STOP PIO'S LEGACY OF DISPLACEMENT.

PIO WANTED TO GIVE AWAY OUR PUBLIC PARK ROY GUERRERO TO A PRIVATE FOR PROFIT CORPORATION AND VOTED TO ELIMINATE NUMEROUS BUS ROUTES.

WHILE I HAVE SERVED ON NUMEROUS BOARDS AND COMMISSIONS WITH THE CITY OF AUSTIN, WHAT IS MOST IMPORTANT IS THAT I'VE; WORKED TO EMPOWER AND GIVE VOICE TO THE MOST IMPACTED.

I, ALONG WITH MEMBERS OF PODER, HAVE HELPED ORGANIZE NUMEROUS NEIGHBORHOOD GROUPS, WORKED ON NUMEROUS GRASS ROOTS CAMPAIGNS, AND WORKED TO ESTABLISH POLICIES AND ORDINANCES THAT PROTECT AND BENEFIT THE PEOPLE.

TOGETHER WE CAN APPOINT RESPONSIBLE COMMUNITY MINDED INDIVIDUALS TO BOARDS AND COMMISSIONS WHO WILL BRING BALANCE TO DECISION MAKING POLICY PROCESS AND CREATE COMMUNITY MEETINGS TO SERVE AS ADVISORS ON BEHALF OF THEIR NEIGHBORHOODS.

MY CAMPAIGN DOES NOT RELY ON BIG MONEY.

IT RELIES ON GRASS ROOTS SUPPORT.

WE SUPPORT PEOPLE'S INTERESTS, NOT MONEY INTERESTS.

PROMOTE A CITY WIDE LIVING WAGE OF \$15 AN HOUR.

PROTECT OUR PUBLIC GREEN SPACE AND ENVIRONMENT. IMPROVE OUR TRANSPORTATION SYSTEM.

I GREW UP SHINING SHOES AND SELLING NEWSPAPERS UP AND DOWN CONGRESS AVENUE.

AS A TEENAGER, I HELPED SUPPORT MY FAMILY BY PICKING COTTON IN THE FIELDS.

I ATTENDED HIGH AUSTIN HIGH SCHOOL, GRADUATED FROM AUSTIN HIGH, AND ROWED IN AUSTIN COMMUNITY COLLEGE, AND LATER WENT TO UT AUSTIN.

I WORKED FOR EDUCATION SERVICE AGENCY, AND THEN I WAS LUCKY ENOUGH TO LAND A JOB WITH IBM AS A COMPUTER AND PRINTER TECHNICIAN.

FOR 34 YEARS I PROVIDE TECH SERVICE TO CAMPUS AND BUSINESS ALL OVER AUSTIN UNTIL I RETIRED IN 2008.

DURING THAT TIME I MET AND MARRIED MY WONDERFUL WIFE, LORI RENTERIA, AND WE RAISED THREE BRIGHT KIDS TOGETHER.

THERE IS NOTHING I AM MORE PROUD THAN MY FAMILY.

I AM NOW A GRANDFATHER AND VERY RECENTLY BECAME A GREAT GRANDFATHER TOO.

MY FAMILY, ALONG WITH OUR NEIGHBORS AND FRIENDS, IS WHAT ALWAYS INSPIRED ME TO FIGHT FOR SOCIAL AND ECONOMIC JUSTICE AND TO DO ALL I CAN TO IMPROVE OUR NEIGHBORHOOD AND OUR CITY.

IT'S THE REASON I SERVED ON PTAS, NEIGHBORHOOD ASSOCIATION, AND NONPROFIT BOARDS.

THE FIRST IS AFFORDABLE HOUSING.

AS OUR COMMUNITY AS OUR CITY CONTINUES TO GROW, LOW INCOME AND WORKING FAMILIES ARE BEING DISPLACED, INCLUDING THOSE THAT HAVE BEEN HERE FOR GENERATION.

EAST AUSTIN HAD FELT THE BURDEN MOST, BUT LACK OF AFFORDABLE HOUSING IS A CITY WIDE ISSUE.

THAT'S WHY WE NEED TO BUILD AFFORDABLE HOUSING EVERYWHERE AND NOT JUST CONCENTRATED IN JUST ONE AREA.

WE NEED TO BUILD AFFORDABLE HOUSING IN PLACES WITH ACCESS TO OTHER RESOURCES, LIKE SCHOOLS, JOBS, HEALTH CARE, AND HEALTHY FOOD CHOICE.

MY GOAL IS TO HELP BUILD INCLUSIVE, MULTIGENERATION NEIGHBORHOODS WITH RACIAL AND ECONOMIC DIVERSITY.

THAT'S WHY I'VE HELPED NONPROFIT HOUSING PROVIDERS LIKE AUSTIN HABITAT FOR HUMANITY, THE HOUSING AUTHORITY AND MOBILE LOAVES AND FISHES BUILD HUNDREDS OF AFFORDABLE HOUSING AND WHY I VOTED IN SUPPORT OF THE 2 MILLION \$250 MILLION AFFORDABLE HOUSING BOND.

MY SECOND PRIORITY IS AFFORDABLE AND ACCESSIBLE TRANSPORTATION.

WHILE HOUSING RECEIVES A LOT OF ATTENTION, TRANSPORTATION IS THE SECOND HIGHEST EXPENSE FOR MOST FAMILIES.

TRANSPORTATION COSTS LIKE CAR PAYMENTS, REGISTRATION, INSURANCE, MAINTENANCE, REPAIR, AND PARKING ADD UP.

THAT MEANS THAT MANY FAMILIES ARE LEFT WITH FEW MOBILITY CHOICE.

WE NEED TO PROVIDE AFFORDABLE AND ACCESSIBLE TRANSPORTATION OPTION.

THAT'S WHY I SUPPORTED THE 2016 MOBILITY BOND AND WHY I USE MY POSITION ON THE CAPITAL METRO BOARD TO ADVOCATE FOR A MORE EQUITABLE AND RELIABLE TRANSPORTATION SYSTEM.

AND, FINALLY, MY THIRD PRIORITY IS ECONOMIC OPPORTUNITY.

MANAGING TO LOWER THE COST OF HOUSING AND TRANSPORTATION WAS WILL ONLY DO SO MUCH FOR AFFORDABILITY.

WHILE WE TRY TO MAKE THESE THINGS COST LESS, WE ALSO NEED TO MAKE SURE WORKING AUSTINITES CAN MAKE MORE.

WE NEED TO PROVIDE MORE EDUCATION AND ECONOMIC OPPORTUNITY TO AUSTIN FAMILIES.

THAT'S WHY I CONSISTENTLY ADVOCATED FOR WORKERS AND SMALL BUSINESS.

I VOTED TO RAISE THE CITY LIVING WAGE TO \$15 AN HOUR AND TO EXPAND WORKERS' PROTECTION, INCLUDING PAID SICK LEAVE.

THE WORK HAS EARNED ME THE ENDORSEMENT OF THE WORKERS' DEFENSE FUND AND THE CENTRAL LABOR COUNCIL.

I WOULD BE HONORED TO HAVE YOUR SUPPORT ONCE AGAIN SO WE CAN KEEP WORKING TOGETHER TO FIGHT FOR OUR COMMUNITY AT CITY HALL.

IN DISTRICT 3 IT MEANS BEING ABLE TO ACCESS QUALITY HOUSING WITHOUT SPENDING MORE THAN 30% OF YOUR INCOME ON IT.

AND JUST AS IMPORTANT, IT MEANS BEING ABLE TO STAY IN THE HOMES AND NEIGHBORHOODS YOU GREW UP IN.

AND HOUSING COSTS ARE THE BIGGEST CHALLENGE.

BUT IN ADDITION TO THAT, AFFORDABILITY ALSO MEANS HAVING ACCESS TO WHOLE HEALTHY FOODS, MONTHLY UTILITY BILLS THAT DON'T CREATE TOXIC STRESS, AND SAFE, COMFORTABLE, AND COST EFFECTIVE TRANSPORTATION TO GET US QUICKLY TO SCHOOL, WORK, AND OUR MEDICAL APPOINTMENTS.

IN ADDITION, I HAVE EXPERIENCE SERVING ON THE TRAVIS CENTRAL APPRAISAL DISTRICT BOARD OF DIRECTORS, THE AISD INNOVATION DISTRICT ADVISORY COMMITTEE AS A COMMUNITY REPRESENTATIVE, AND HAVE SERVED AS A COUNTY PRECINCT CHAIR.

AS A PROFESSIONAL REAL ESTATE BROKER, MY JOB IS TO FIND PEOPLE HOMES AND UNDERSTAND THE COMPLEXITIES OF INCREASED TAXES, DEMOLITIONS, AND PRESSURES OF NEW DEVELOPMENTS ON THE PEOPLE THAT LIVE IN THE DISTRICT AS WELL AS THROUGHOUT THE CITY.

WE NEED TO MAKE SURE WE ARE USING ALL THE TOOLS AT OUR DISPOSAL TO BRING ABOUT AFFORDABILITY.

EXPANSION OF VARIOUS EXEMPTIONS TO SERVE THE ELDERLY AND DISABLED IS CRITICAL.

WE MUST WORK DILIGENTLY TO DEVELOP CITY OWNED LAND WITH AFFORDABLE HOUSING IN HIGH OPPORTUNITY AREAS, WITH TWO AND THREE BEDROOM OPTIONS TO ACCOMMODATE FAMILIES' NEEDS.

WE MUST CREATE DEEPLY AFFORDABLE UNITS THAT ARE ACCESSIBLE TO THE 60% MFI LEVEL AND BELOW IN NEW CONSTRUCTION PROJECTS.

OUR MEDIAN INCOME LEVEL AS A DISTRICT IS WELL BELOW THE CITY WIDE MEDIAN.

SO IT'S IMPORTANT WE FOCUS THESE UNITS TOWARD A PRICE POINT THAT OUR RESIDENTS CAN AFFORD, NOT WHAT'S AFFORDABLE TO THE REST OF THE CITY.

AS A COMMUNITY, WE NEED TO LEARN FROM THE CODENEXT PROCESS.

WHAT WENT WRONG?

THE NEIGHBORHOOD PLANS BEING OBSERVED AND INCLUDED IN THE CODE REWRITE PROCESS IS CRITICAL.

WE HAVE SPENT INCREDIBLE AMOUNTS OF TIME AND MONEY ON THESE RESOURCES AS A COMMUNITY, AND THEY REPRESENT THE VOICES OF OUR RESIDENTS.

THE DENSITY BONUS, FEE IN LIEU, AND PARKLAND DEDICATION FEES NEED TO BE RECALIBRATED TO MAKE SURE WE ARE GETTING THE MOST OUT OF THESE TOOLS.

I'M IN FAVOR OF MEASURED GROWTH TO CORRIDORS AND ACTIVITY CENTERS AS SPELLED OUT IN IMAGINE AUSTIN.

TO ADDRESS OUR TRAFFIC AND TRANSPORTATION NEEDS, WE NEED TO HAVE A MULTIFACETED APPROACH, INCLUDING BUT NOT LIMITED TO IMPROVING TRAFFIC LIGHT TIMING ON OUR CORRIDORS, TO BETTER ALIGN WITH PEAK DEMAND TIMES; INCREASE CONNECTIVITY BETWEEN BIKE LANES AND OUR TRAIL SYSTEMS; ENHANCING SAFE PATHS TO SCHOOL WITH EXPANSION OF OUR SIDEWALKS AND PEDESTRIAN BEACONS.

AS A COMMUNITY WE SHOULD ALSO EXPLORE OPTIONS REGARDING SCOOTER DOCKING STATIONS AND RIDE SHARE DROP ZONES.

FINALLY, CREATING BUS ROUTES THAT ARE SAFE, EFFICIENT, AND AFFORDABLE.
